## **Directions for Use**

WHAT IT DOES: Blast is designed to dissolve carbonate build up in the soil.

#### WHERE & WHEN TO USE:

Blast is recommended for use on fine turfgrasses such as those on golf courses, athletic fields, residential and commercial and other highly maintained turf areas. DO NOT APPLY NEAR WATER, STORM DRAINS, OR DRAINAGE DITCHES. DO NOT APPLY IF HEAVY RAIN IS EXPECTED, APPLY THIS PRODUCT ONLY TO YOUR LAWN/GARDEN, AND SWEEP ANY PRODUCT THAT LANDS ON THE DRIVEWAY. SIDEWALK, OR STREET, BACK ONTO YOUR LAWN/GARDEN.

APPLICATION **RATES AND** FREQUENCY: Spraying: Apply Blast through spray equipment at 32 to 64 fl oz/ acre. Blast should be applied with a spray volume of 50 gallons of water per acre for fairways and 88 gallons of water per acre for greens. Apply once a week for three weeks to get initial effect and then apply every two weeks as needed through the growing season. After spray application, immediately irrigate the area lightly to wash Blast off the canopy and into the soil profile.

Injection: Inject Blast at ½ to 1 gallon/ acre monthly through the growing season or as needed.
