### Best Uses

- // Indemnify® is a preventative and curative nematicide. It controls key root-feeding nematodes of turfgrass including but not limited to sting, root-knot, and ring, as well as the crown- and stem-feeding *Anguina pacificae*
- // Application is simple; apply 0.1" irrigation within 12-24 hours of application, no aerification or deep watering-in needed
- // Control may last up to 6 months or more depending on nematode populations and environmental conditions
- // Course closure is not required when using Indemnify®. For optimal results, maintain best cultural practices to complement Indemnify applications

- // Management of many plant-parasitic nematodes in turfgrass
- // Can be applied on all turfgrass species (See label)
- // Formulation contains surfactant to optimize root zone penetration
- // Flexible timing integrates well into current Best Management Practice (BMP) programs

Indemnify is a nematicide that blocks cellular respiration resulting in the paralysis and death of the nematode. The needle-like appearance of paralyzed nematodes is a typical response. \*Meloidogyne sp. treated with 20 ppm fluopyram. (Bayer)
