Application at the recommended rates will last approximately 4 to 6 weeks.

GROUND COVER: Broadcast at 5 lbs. per 1,000 sq. ft. (½ lb. per 100 sq. ft.)

SHRUBS & EVERGREENS: Sprinkle ¼ cup evenly around dripline of plant and work into top 1 inch of soil.

TREES: Apply ½ lb. per 1 inch of trunk diameter. Distribute evenly under branches out to dripline.


NOTE: Liquid measuring cups are very close in estimating the weight of dry granular fertilizers. *Example:* an 8 oz. (1 cup) measuring cup holds approximately 8 oz. (½ lb.) of dry granular fertilizer.
