DIRECTIONS FOR USE

This TCS product is a professional quality turf fertilizer. Its suitability for use in any given application depends on existing soil chemistry, turf type, and intended use of the turf area. The best results with this product are obtained when it is applied to actively growing grass, and watered into the turf soon after application. Avoid mowing immediately following application to prevent pick-up. Application with rotary or pendulum spreaders is recommended for uniform distribution. The use of a drop spreader is not recommended. Consult your spreader manual or spreader manufacturer to determine spreader settings to achieve application rates desired. You may need to adjust the setting depending on the walking speed, spreader condition, and product. Do not apply to frozen ground.

Do not apply near water, storm drains or drainage ditches. Do not apply if heavy rain is expected. Apply this product only to your lawn, and sweep any product that lands on the driveway, sidewalk, or street back onto your lawn. This product may stain driveways, walkways, streets, porches, and other non-target areas.

This fertilizer contains phosphorus and may not be used on turf in the state of Maryland except when 1) Providing nutrients to a specific soils and target vegetation as determined to be necessary in accordance with a soil test that was conducted by a laboratory identified under section 8-803.7 of the Agriculture Article, Annotated Code of Maryland, performed no more than 3 years before the application; 2) Establishing vegetation for the first time, such as after land disturbance, provided the application is conducted in accordance with the recommended application rates established by the State; or 3) Reestablishing or repairing a turf area.

Per Virginia applications, this lawn fertilizer contains phosphorous and is intended only for nonagricultural use on (i) turf during its first growing season, (ii) on turf areas being repaired or renovated, and (iii) on turf where a soil test performed within the last 3 years indicates a phosphorous deficiency. This fertilizer is not intended for the routine maintenance of turf.

Per Pennsylvania applications, this lawn fertilizer contains phosphorous and is intended only for nonagricultural use on (i) turf establishing vegetation for the first time, (ii) on turf areas being repaired or renovated.

In the state of MD, NH, NJ, and VA DO NOT exceed 0.7 LBS. of Nitrogen per 1,000 SQ. FT.

In the state of MD do not exceed the annual limit of 2 LBS. of Phosphorus per 1,000 SQ. FT.

In the state of MI DO NOT apply more than 0.25LBS. of Phosphorus per 1,000 SQ. FT. per application

In the state of FL & PA do not exceed the annual limit of 0.5 LBS. of Phosphorus per 1,000 SQ. FT. (no more than 0.25 LBS. of Phosphorus per 1,000 SQ. FT. per application in FL).

In PA, do not exceed 0.9 lbs of total nitrogen and 0.7 lbs of available nitrogen per 1000 ft2 per application. Nitrogen application is limited to 0.5 lbs of total nitrogen between December 15 and March 1.
