### HAZARDS TO HUMANS AND DOMESTIC ANIMALS

00ZZZERO is a trap that kills *Aedes* spp. mosquito larvae. The larvicide, pyriproxyfen, kills larvae that hatch from eggs flooded by rainwater entering the trap. 00ZZZERO Trap is for used to kill larvae, thereby preventing emergence of adult container-breeding *Aedes* mosquitoes that may transmit Zika, dengue, or chikungunya virus to humans.

Fill the 00ZZZERO Trap to the top with water. Hang the 00ZZZERO Trap from a tree or place on the ground in the garden or under trees/shrubs, etc. For best results, check the water level in the trap periodically, i.e. a week or more after a rainy day. If empty, refill with water.

### STORAGE AND DISPOSAL

DO NOT contaminate water, food or feed by storage or disposal.

**Storage:** Store unopened container in a cool, dry place until ready for use. Do not store with food.

**Pesticide Disposal:** Wastes resulting from the use of this product must be disposed on site or at an approved waste disposal facility.

**Container Handling:** Non-refillable container. Do not reuse or refill this container. **If empty:** Place in trash or offer for recycling, if available. **If partly filled:** Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain.
