#### GENERAL INFORMATION

LESCO Lake & Pond WS Aquatic Colorant - Blue lake and pond dye returns sequestered water systems that have become murky to their original reflective luster by dispersing a non-toxic, non-staining water-soluble blue dye through natural water movement or mechanical circulation.

The use of **LESCO Lake & Pond WS Aquatic Colorant - Blue** will not interrupt irrigation scheduling or recreational use of ponds, reservoirs, lakes or lagoons. Littoral systems, water fowl, color aesthetics, and pets benefit from the restored clarity.

LESCO Lake & Pond WS Aquatic Colorant - Blue performs best in impounded water systems and is not recommended for rivers and streams.

Color vibrancy will gradually fade due to sunlight, adjustments to the water volume, or chlorinated treatment products-usually within 2-4 weeks.

Fast dissolving and concentrated, **LESCO Lake & Pond WS Aquatic Colorant - Blue** in convenient water-soluble bags reduces applicator contact and package disposal.

#### DIRECTIONS FOR USE

When used as directed, LESCO Lake & Pond WS Aquatic Colorant - Blue will not stain clothing, stone or other hardscapes.

**LESCO Lake & Pond WS Aquatic Colorant - Blue** may appear to be slightly reddish when in the packet. The colorant is blue when added to water.

#### **USE RATE**

For each 1 acre-foot of water feature surface area, use one packet of LESCO Lake & Pond WS Aquatic Colorant - Blue.

Gradually increasing or decreasing the application rate to correct color intensity for aesthetic purposes or due to changes caused by weathering may be necessary. An experienced applicator should adjust the use rate as needed.

Placing packets in the deepest areas of the water feature and close to mechanical circulation systems will disperse LESCO Lake & Pond WS Aquatic Colorant - Blue quickly, but natural changes in temperature and currents caused by wind will also soread the color.

#### FIRST AID

Have the product container with you if calling a poison control center or doctor, or going for treatment.
