

LESCO Lake & Pond WS Aquatic Colorant - Black creates a mirror-like surface while reducing sunlight penetration into the thermocline layer where algae grows.

Fast dissolving and concentrated, **LESCO Lake & Pond WS Aquatic Colorant - Black** in convenient water soluble bags simplifies applicator contact and package disposal.

The use of **LESCO Lake & Pond WS Aquatic Colorant - Black** does not interrupt recreational activities or irrigation schedules and will not harm aquatic life, waterfowl, and oets.

When applied as directed below, LESCO Lake & Pond WS Aquatic Colorant - Black does not stain swimwear, stone, or other ornamental hardscapes.

DIRECTIONS FOR USE

Do not handle with wet hands. Always reseal outer packaging immediately after the packets are removed.

Placing packets of **LESCO Lake & Pond WS Aquatic Colorant - Black** in the deepest areas of the water feature and close to mechanical circulation systems will disperse the colorant quickly, but natural changes in temperature and currents caused by wind will also spread the color eventually.

APPLICATION RATES

For each 1 acre-foot of water-feature volume, use one water soluble bag of **LESCO Lake** & Pond WS Aquatic Colorant - Black.

Gradually increasing or decreasing the application rate to correct color intensity for aesthetic purposes or due to changes caused by weathering may be necessary.

Sunlight, biological processes, precipitation dilution and chlorine will gradually diminish the color intensity. Reapply LESCO Lake & Pond WS Aquatic Colorant - Black every 2-4 weeks as needed to maintain the reflective quality of the water surface.

For best results, LESCO Lake & Pond WS Aquatic Colorant - Black should be used in confined water systems only and not in rivers or streams.

FIRST AID
