LESCO® Nutra-TECH 8-8-16 is a highly soluble liquid Nitrogen, Phosphorus, and Potassium fertilizer plus Sulfur that can be applied directly to the soil, to the plant tissues (with water), or through an irrigation system. This product supplies Potassium for foliar and root uptake and use during critical growth stages. It can be applied throughout the growing season to correct Potassium deficiencies. Fall fertilization provides Potassium.

### DIRECTIONS FOR USE

Shake well before each use. Avoid getting in the eyes, mucous membranes, or on the skin. Use side-shielded safety glasses. Use with adequate ventilation. Keep the container capped when not in use. Do not contaminate feed, seed, or water supplies. LESCO Nutra-TECH 8-8-16 must be diluted with water before mixing with other nutrients or chemicals. Apply fertilizer in accordance with best management practices established by your State University or Cooperative Extension Service. Observe any State or Local fertilizer regulations about fertilizer content, application rates, or timing of application specific to your locale.
