APPLICATION GUIDELINES

LESCO Chelated Iron Plus is compatible with many pesticide and fertilizer formulations. However, when working with new or familiar products, it is suggested that a small quantity be jar mixed to check for incompatibilities prior to tank mixing.

Mixing Instructions: Add one-quarter of tank volume with water. Add **LESCO Chelated Iron Plus**. Agitate tank contents while adding remaining water, urea or other fertilizers. Add herbicide/pesticide last while continuing to agitate contents of tank. Spray tank mixes as soon as possible. Always agitate contents well, prior to spraying, especially of contents have been standing for more than 24 hours. Do not premix.

Low moisture conditions may limit nutrient uptake so a minimum dilution of 1:100 in water is necessary. Maximum dilution should not exceed 1:500. Shake or agitate before adding to tank mix. See compatibility section for details & problems on mixing and applying. Do not premix **LESCO Chelated Iron Plus** with herbicides/pesticides prior to adding spray tank.

COMPATIBILITY

LESCO Chelated Iron Plus is a tank mix compatible with most soluble fertilizers, herbicides, insecticides, and fungicides. However, test any alkaline materials (pH 10 or greater) before tank mixing. Mixing with other chemicals may cause staining, so it may be necessary to test the final tank mix on a small concrete area.

This product exhibits reduced staining characteristics only when used as recommended.

DIRECTIONS FOR USE AGITATE BEFORE USE

Apply only as directed. **LESCO Chelated Iron Plus** is formulated for soil or foliar application. It is designed to supplement all fertilizer programs with an effective iron treatment for better color. Use **LESCO Chelated Iron Plus** in conjunction with the recommendations of your approved nutrient management plan.

Turf:

Lawns, Parks, Sports Fields, Golf

1½ - 2 fl. oz per 1,000 sq. ft. (1/2 - 2/3 gallon per acre).
Apply every 4 weeks or as needed. 15 gallon container treats up to 30 acres at 1½ oz. per 1,000 sq. ft.

Trees and Shrubs

Injection Root Feeding

1 gallon to 100 gallons of water. Apply in spring or fall.

Maintenance:

Foliar Spray

32 fl. oz. per 100 gallons water. Apply in spring, summer and fall.

Container Disposal: Dispose of container according to Federal EPA procedures as outlined in the Resource Conservation and Recovery Act (RCRA) and follow state and local guidelines. Triple rinse and puncture as required.
