### **PRODUCT INFORMATION**

LESCO Green Flo 5% Magnesium is a liquid formulation designed to correct and prevent Magnesium deficiencies. Magnesium is an important secondary nutrient, very essential for photosynthesis, since it is part of the chlorophyll molecule. Inadequate amounts of Magnesium will appear as a loss of green color at the bottoms of older leaves. Severe deficiencies will also affect younger leaves and can result in the formation of lesions. Magnesium deficiencies normally occur in sandy soils and in extremely high pH soils. High levels of calcium and potassium will also reduce magnesium uptake

### **DIRECTIONS FOR USE**

Shake well before each use. LESCO Green Flo 5% Magnesium is compatible with many fertilizer formulations. However, when working with new or unfamiliar products, it is suggested that a small quantity be jar mixed to check for incompatibilities prior to tank mixing. The addition of a non-ionic surfactant will aid surface coverage which will help leaf absorption.

### **RECOMMENDED RATES**

**Turf (Greens & Tees):** Apply 2-4 oz. per 1,000 sq. ft. in enough water to cover.

**Trees and Ornamentals:** Apply 1 to 2 quarts per 100 gallons of water as a foliar spray.

### **MIXING PROCEDURES**

1. Add ½ of total water to spray tank.
2. Begin circulating material in tank.
3. Add recommended amount of Green Flo 5% Magnesium.
4. Add compatible micronutrients.
5. Add flowable materials.
6. Add emulsifiables.
7. Add any soluble powders and/or water soluble fertilizers. All should be pre-dispersed in water before adding to the spray tank solution.
8. Complete filling of spray tank to desired volume. Continue circulating prior to and during spray application.
