SUGGESTIONS FOR USE IN TURF AND LANDSCAPE APPLICATIONS*

1. Apply only to actively growing turf.
2. Apply when foliage is dry and soil is moist.
3. Apply only with well maintained and properly calibrated equipment for even distribution and optimum results.
4. Apply irrigation immediately after applying fertilizer for best results.

ESTABLISHED TURF: Broadcast 0.5 - 0.7 pounds nitrogen per 1000 square feet (2.38 - 3.33 pounds of Stampede per 1000 square feet). Apply irrigation to dissolve fertilizer and incorporate into turfgrass rooting zone.

In Virginia, this lawn fertilizer, which contains phosphorous, is intended only for nonagricultural use on (i) turf during its first growing season, (ii) turf areas being repaired or renovated, and (iii) turf where a soil test performed within the last 3 years indicates a phosphorous deficiency. This fertilizer is not intended for the routine maintenance of turf.
