FIRST AID

GENERAL INFORMATION

MOTION™ is a combination of highly-refined, modified vegetable oil and selected emulsifiers. It is designed to be used with herbicides that suggest or require the use of MSO on the label. Because of its oily nature, **MOTION™** dissolves into the waxy cuticle, carrying the active ingredient with it. This allows the active ingredient to reach the inside layer of the plant more readily, where it is carried to the rest of the plant to do its job more reliably.

- Modified vegetable oil is derived from natural vegetable fats
 - Better performance than petroleum oils, unmodified soybean oils or nonionic surfactants
- Oily spray applications delay evaporation
 - Remains on target weeds longer for improved uptake

Ideal For:

- Use with pesticides in horticulture, nursery, turf and pest control applications
- Ensuring pesticide sprays penetrate the target plant's surfaces
- Any pesticide tank mix that calls for methylated seed oil or MSO

DIRECTIONS FOR USE

NOT FOR AQUATIC USE

If the pest control product calls for or allows the use of an MSO, follow the instructions on the pest control product label. Care should be used on sensitive species as the product could increase sensitivity to light.

If the applicator does not have experience with a specific tank mixture and/or the combination of products being used is not recommended by the pest control label, a compatibility (jar) test and a phytotoxicity test should be run before using the product.

MIXING INSTRUCTIONS

Always follow instructions on the pesticide label.

If instructions are not provided, follow these general instructions: Fill spray tank 2/3 or 3/4 full of water. Add dry flowables (DF) and wettable powders (WP) disperse thoroughly. Continue the addition of other active ingredients, then adjuvants including **MOTION™**.

Note: Tank mixtures including **MOTION™** should be utilized within 36 hours for best results.

USE RATES

Low volume sprays, less than ½ gallon per 1000 square feet: If the label allows the use of an MSO but does not recommend a rate, add 1 ounce per 1000 square feet of **MOTION™** to the spray tank. Extra product may be needed on weeds with heavier wax cuticles, or under dry or dusty conditions or for more mature weeds.

High volume sprays, ½ gallon or more per 1000 square feet: Use of this product at rates less than in the chart below will cause a lack of control due to inadequate amounts of MSO. Providing an effective amount of **MOTION™** is essential in achieving the goal of pest control. Use the lowest effective dose from the chart below if the total volume sprayed is 20 gallons or more per acre.

STORAGE AND DISPOSAL

DISPOSAL: Do not contaminate water, food or feed by storage or disposal. Triple rinse (or equivalent) adding rinse water to application tank. Offer container for recycling or dispose of in a sanitary landfill or by other procedures approved by local regulations.
