IF INHALED: Remove victim to fresh air and keep at rest in a position comfortable for breathing. If person is not breathing, call 911 or an ambulance, and then give artificial respiration, preferably mouth to mouth if possible.

GENERAL INFORMATION

DRAPHT PICK conditions mixing water and helps to prevent the rapid breakdown of alkaline pH sensitive pesticides such as glyphosate, organo-phosphates, carbamates and synthetic pyrethroids. To assist the operator, an indicator dye that causes the solution to turn color according to the pH range is built into the formulation.

DRAPHT PICK buffers and improves tank mix compatibility when combining pesticides and nutrients.

The premium surfactants in **DRAPHT PICK** spread the active ingredients thoroughly across the target and increase wetting and penetration through waxy or weather hardened surfaces.

DIRECTIONS FOR USE

Follow the directions on the most restrictive active ingredient label.

Tank mixtures should only be applied within the label recommendations of every product in the tank mixture

Use only if a nonionic surfactant and buffering agent are allowed or not excluded on the label.

DRAPHT PICK DOES NOT CONTAIN AMMONIUM SULFATE.

Do not pre-mix with pesticides, nutrients or other adjuvants before mixing with water.

If the user does not have experience with the mixture being applied, perform a jar test using the order and amounts in the mixture and perform a phytotoxicity test to ensure crop safety.

MIXING INSTRUCTIONS

The use of pH testing strips and the testing of a small quantity of the proposed mix is highly recommended until the operator is familiar with their local water conditions.

All instructions assume that the starting solution is clear or white. The colors of the active ingredients and adjuvants such as marking dyes can alter the tint of the color change.

Fill the tank 2/3 full of water and the active ingredient mix.

Begin agitation and gradually add an amount of **DRAPHT PICK** until the solution turns the color approximately matching the desired color range. (See pH chart below)

Add the nutrients and/or active ingredients and the balance of the mixing water to almost fill the tank.

If the mix turns clear or an undesired color after this addition, adjust the amount of **DRAPHT PICK** or tank mix until the solution turns the desired color again.

The amount of **DRAPHT PICK** needed will depend on the mineral content (hardness) of the water source which can vary widely. Record the quantity used for future mixes.

USE RATES

pH Indicator Color Range

Yellow ~Over pH 6.2

Orange ~4.5 to 6.1

Red ~less than 4.4

5 to 32 ounces of **DRAPHT PICK** per 100 gallons of spray solution

The rate may change as the mixing water hardness varies from soft (0-100 ppm) to extremely hard (>400 ppm). Begin with the lowest rate and gradually increase until the desired color appears.

STORAGE AND DISPOSAL

Storage: Store locked up. Store in a corrosive resistant HDP, stainless steel or polypropylene container with a resistant inner liner. Store in a cool well-ventilated place. Keep in original container tightly closed. Do not reuse empty container. Do not store with food, feed, or other material to be used or consumed by humans or animals. Do not contaminate water supplies. STORE BETWEEN 40° AND 90° F.

Disposal: Do not contaminate water, food or feed by storage or disposal. Dispose of contents in container to an approved waste disposal facility in accordance with all local, regional, national and international regulations. Triple rinse (or equivalent) adding rinse water to application tank. Offer container for recycling or dispose of in a sanitary landfill or by other procedures approved by local regulations.
