Apply to dry turf and water in as needed. Remove fertilizer from non-target areas such as driveways, sidewalks and hardscapes.

Do not apply near water, storm drains or drainage ditches. Do not apply if heavy rain is expected. Apply this product only to your lawn and sweep any product that lands on the driveway, sidewalk or street, back onto your lawn.

Virginia: This product is being used in accordance with the recommended application rates established by the VA Nutrient Management Standards & Criteria.

This lawn fertilizer contains phosphorous and is only for non-agricultural use on (i) turf during its first growing season, (ii) on turf areas being repaired or renovated, and (iii) on turf where a soil test performed within the last 3 years indicates a phosphorous deficiency. This fertilizer is not for the routine maintenance of turf.

Maryland: This product is being used in accordance with the recommended application rates established by the University of Maryland.

In New Hampshire, this turf/lawn fertilizer contains phosphorous and is only for nonagricultural use on newly established turf/lawns, for repairing turf/lawns, for seeding, or for use when a soil test indicate a phosphorus deficiency. Do not exceed 50 lbs. of product (<=1 lb of available phosphate) per 1000 sq. ft. annually.
