General Information:

SMS 200 improves overall conditions to combat soil hydrophobicity or LDS and enhances irrigation efficiencies.

SMS 200 is formulated for use by golf course superintendents or professional turf applicators.

Directions For Use and Use Rates:

Injection Rate Application

Apply SMS 200 at 15 - 24 fluid ounces (450 - 720 ml) in a sufficient amount of water to treat 1 acre every 14 - 21 days. Rates can be adjusted in 2 ounce increments up or down until desired level of performance is acceptable.

Spray Rate Application

Apply SMS 200 at 15 - 24 fluid ounces (450 - 720 ml) per acre in at least 65 gallons of water every 14 - 21 days. Rates can be adjusted in 2 ounce increments up or down until desired level of performance is acceptable. SMS 200 can be tank mixed with commonly utilized turfgrass management product. However, a basic jar compatibility test is recommended as well as an application to a small area of turfgrass prior to full scale application to assess effect on applicator's specific turfgrass.

Factors, such as weather conditions and environmental conditions, should be noted when choosing application times, and during periods of high temperature extremes. All surfactants should be irrigated after application to ensure turfgrass safety and efficacy.
