

General Information

SMS 700 is a proprietary blend of soil surfactants specially formulated to provide a flexible tool to combat soil hydrophobicity or LDS. SMS 700 can be applied at a variety of rates to improve wetting of the soil. SMS 700 is formulated for use by golf course superintendents or professional turf applicators.

Directions for Use and Use Rates

Rate of Application: Apply SMS 700 at 7 fl oz (210 ml) per 1000 sq. ft. in at least 3 gallons of water. Application should be made early in the growing season. At least 1-2 irrigation cycles should be applied soon after treatment to enhance product performance. Follow up the first treatment 7-10 days later with another 7 fl oz (210 ml) per 1000 sq. ft. in at least 3 gallons of water.

Additional application or applications are recommended throughout the growing season at 7 fl oz (210 ml) per 1000 sq. ft. in at least 3 gallons of water to obtain optimal performance depending upon environmental conditions.

Such factors as weather conditions and environmental conditions should be noted when choosing application times.

It is strongly recommended that SMS 700 not be mixed with any other wetting agent, pesticide or fertilizer.
