NOTICE: Pesticide manufacturers routinely detail adjuvant use guidelines on the pesticide label. The manufacturer's guidelines take priority over any directions or suggestions provided on the SCRIMMAGE™ label. The following guidelines are not intended to supersede or displace pesticide label instructions, but should be used as general use recommendations when or if pesticide labels do not provide specific instructions. Adjuvant terminology does vary among pesticide and other manufacturer labels — all references to NIS, nonionic surfactant, spreaders, wetters, spreader-wetters, and/or organosilicone surfactant are all commonly used terms that refer to the use of a surfactant adjuvant such as SCRIMMAGE™. SCRIMMAGE™ is allowed if the pesticide label allows the use of any of the products described above and if an organosilicone surfactant is not prohibited.

MIXING INSTRUCTIONS

As with all spray applications, be certain that the spray tank is clean and free from previous spray before following these mixing instructions.

- Fill tank 2/3 to 3/4 full of water and initiate tank agitation systems. If foaming is anticipated, add an antifoam agent, such as REVERSE™. at this time to prevent and manage foaming problems during the mixing process.
- 2. Add pesticide/nutritional actives as directed by those respective label(s). Continue agitation.
- 3. Add the required dosage of **SCRIMMAGE™** (refer to the dose chart below). Mix for 1 to 2 minutes with minimal agitation.
- 4. Continuing lower than normal agitation, fill the tank with water. For best results, apply within 36 hours of mixing, continuing minimal agitation throughout the spray process.

The general application concentration rates suggested on this label are based on pesticide and nutritional input labels that recommend the use of a nonionic surfactant such as SCRIMMAGE™. Rates of this product may be increased or decreased for optimum results. Follow the pesticide labeling for specific recommendations. SCRIMMAGE™ can be used where a nonionic surfactant may not be specifically recommended. The user or applicator advisor must have experience with the combination or must have conducted a phytotoxicity trial to insure suitability for use. This product is not allowed for use if the pesticide/nutritional labels specifically prohibit the use of nonionic or organosilicone surfactant adjuvants.

STORAGE AND DISPOSAL

Storage: Store in a cool well-ventilated pl. ace. Keep in original container tightly closed. Do not reuse empty container. Do not store with food, feed, or other material to be used or consumed by humans or animals. Do not contaminate water supplies. For optimal storage, store between 40° and 90° F.
