*Note: Naturally mined minerals, like attapulgite typically contain silica (sand) at amounts ranging from 1 to 10%. Fine silica particulates are considered as a carcinogen via repeated and prolonged inhalation. Total silica content in this product is estimated to be about 0.4% or more.

4. FIRST AID MEASURES

Eye Contact	Rinse eyes cautiously with water for several minutes. Remove any contact lenses if easy to do, and continue rinsing. If discomfort or irritation persists contact a physician.
Skin Contact	Wash with soap and water. If injury occurs, or if discomfort or irritation persists or rash occurs, contact a physician.

5. FIRE FIGHTING MEASURES

Suitable extinguishing media

Methods for containment	Prevent further leakage or spillage, if safe to do so.
