APPLICATION RATES AND TIMINGS

APPLY ONLY AS DIRECTED.

Turfgrass: Apply 1 to 3 fl oz per 1000 sq ft in a water volume of 1.5 Gallons/1000 sq ft every 7 - 14 days as needed during the growing season based on nutritional requirements.

Nursery stock/ornamentals: 1 - 2 qts. Per 100 gallon of water. Repeat at 10 - 14 day intervals as necessary. Do not apply during flowering.
