### APPLICATION INSTRUCTIONS

Apply evenly to dry foliage. For best results apply product on a calm, dry day and water in for optimum effectiveness. When used on turf, mow turf a day or two before application. Avoid mowing immediately following application to prevent product pick-up. Always apply with a properly calibrated rotary or drop spreader. To avoid gaps and streaks, NEVER APPLY BY HAND! Always apply evenly over lawn.
