GENERAL APPLICATION: Flower beds, shrubs, gardens: Sprinkle or spread to form a border approx. 15-18 inches out from the edge of the bed with a 20-24 inch band of Rabbit Scram. Apply using the 8 oz. scoop so it is visibly heavy enough to see. One scoop should cover 22 linear feet. Inspect for and treat nests. **For Excessive problems in high rabbit density areas: ON 1st APPLICATION,** apply a second band 15 inches out from the first strip around the bed and broadcast Rabbit Scram Pro lightly throughout the inside of the bed. This will stop the problem and only a single band nearest the bed will be needed for maintenance applications going forward. **SEE FULL APPLICATION INSTRUCTIONS INSIDE.**
