DIRECTIONS FOR USE

General Soil Applications - 2½ to 5 gallons per acre has proven to be the accepted application rate. A soil pH in the low 6 range would use 2½ gallons per acre. LESCO Liquid Lime is best applied with a suggested dilution for 1 gallon of concentrate to 10 – 30 gallons of water, based upon the spray equipment calibration. For best results, regular soil testing is recommended.

Golf Course and Sports Turf - Apply LESCO Liquid Lime to greens, trees, fairways, and athletic fields to improve elemental calcium and control pH during the growing season. Two or three applications annually should aid in fertilizer uptake.

Greenhouse and Nursery - Container crops require higher irrigation rates than typical field grown crops, therefore LESCO Liquid Lime is designed for a wide range of dilution rated to pass through standard irrigation systems for pH adjustment, as needed.

Hydroseeding - Avoid handling large amounts of bagged dry limestone only to wait months to achieve a desired pH. By using LESCO Liquid Lime, instant pH adjustments occur in the root zone to promote seed germination and root development. (See General Soil Applications for suggested rates. In some cases, higher application rates may be required at a specific job sites).

Fish Pond - Improve pond alkalinity with LESCO Liquid Lime. Dilution of this product is recommended and commercial spray equipment can be used from a boat or from the shoreline. Avoid pouring concentrate over a boat propeller for direct mixing. (Note: General Soil Application rates may apply equally to a surface acre of water).

For best results, a professional soil test or water analysis is recommended prior to application.

Statement for North Carolina, South Carolina and Virginia: 2849 pounds of LESCO Liquid Lime is equivalent to 2000 pound of dry liming material (10.4 dry pounds/gallon).

FIRST AID
