- In the State of New York, Safari 20 SG Insecticide is registered under FIFRA Section 24(c), as a Special Local Need (SLN) registration. For the State of New York, this 24(c) supplemental labeling provides additional use precautions and limitation applicable to the use of Safari 20 SG Insecticide.
- Use of Safari 20 SG Insecticide according to this supplemental labeling is subject to all use precautions and limitations imposed by the label affixed to the container for Safari 20 SG Insecticide.
- In the State of New York, Safari 20 SG Insecticide may only be applied as labeled on ornamental plants, flowers and foliage plants in greenhouses. Outdoor use is prohibited.
- Do not expose honeybees to pollen and nectar of ornamental plants treated with Safari 20 SG Insecticide. On flowering plants that will be grown outdoors after sale (such as bedding plants and hanging baskets), do not apply Safari 20 SG Insecticide until after plants have finished flowering and pollen or nectar are no longer present. On flowering plants that are not grown outdoors after sale (such as Poinsettia, Kalanchoe and Cyclamen), non-flowering plants (such as Dieffenbachia, Dracaena and Palm), or ornamental stock plants grown as a source of propagated plant material, Safari 20 SG Insecticide may be applied at any time during production cycle.
- Under the conditions of this SLN label no more than two (2) foliar or broadcast applications and/or one (1) soil application can be made per crop per year.

Re: Registration of Special Local Need Labeling for Safari 20 SG Insecticide (EPA Reg. No. 86203-11-59639) Assigned SLN No. NY-120010.

The New York State Department of Environmental Conservation (Department) has reviewed the application submitted by Valent U.S.A. Corporation and supporting documentation submitted by Landis International, Inc. (Regulatory Agent for the basic registrant Mitsui Chemicals, Inc.) to register Special Local Need (SLN) labeling for Safari 20 SG Insecticide (EPA Reg. No. 86203-11-59639) in New York State. The subject product contains the active ingredient dinotefuran (chemical code 044312).

Safari 20 SG Insecticide is labeled for application as a foliar spray, broadcast spray, soil drench, and via chemigation for insect control in ornamental plants grown in commercial, industrial, and residential areas, indoor and outdoor nursery and greenhouse ornamental production.

The Department conducted a technical review which evaluated impacts to human health, non-target organisms, and environmental fate and subsequently denied registration of outdoor use patterns in New York State for Safari 20SG per Department letter to Valent U.S.A. Corporation dated January 7, 2008. The denial letter determined unacceptable risk to honey bees and other organisms dependent on plant pollen and nectar as well as groundwater as determined by dinotefuran's environmental fate data, the products' groundwater advisory statements and the Department's LEACHP simulations suggesting the potential for dinotefuran and its degradate MNG to adversely impact groundwater/drinking water resources in New York State.

The SLN labeling for use of Safari 20 SG (EPA Reg. No. 86203-11-59639) will allow **limited use of the product in greenhouses**. Precautions listed on the SLN labeling will significantly limit impacts to non-target organisms such as bees and limit potential impact to groundwater.

The Department previously registered SLN No. NY-070007 for this same limited use of Safari 20 SG (EPA Reg. No. 33657-16-59639) in New York State. The basic registrant, Mitsui Chemicals, Inc. (EPA Company #33657) has transferred the product registration to Mitsui Chemicals Agro, Inc. Therefore, the new SLN registration lists the product as Safari 20 SG (EPA Reg. No. 86203-11-59639). New York State supports the continued limited outdoor use of Safari 20 SG for use in greenhouses.

The SLN labeling specifies the New York State required use restrictions for Safari 20 SG Insecticide (EPA Reg. No. 86203-11-59639) for use only in greenhouses. The product is assigned the registration number: **SLN No. NY-120010**.

Therefore, under the authority of Section 24(c) of FIFRA, the Department hereby grants a Special Local Need registration for Safari 20 SG Insecticide (EPA Reg. No. 86203-11-59639).

The SLN labeling contains the only uses allowed in New York State. All precautionary statements, applicable use directions, use precautions and limitations of the labeling affixed to the Safari 20 SG Insecticide container must be followed.

The Certificate of Pesticide Registration and a copy of the New York State stamped "Accepted" SLN labeling and the associated container labeling for Safari 20 SG Insecticide, are enclosed for your records.

Please be reminded that a copy of the accepted SLN label **must** be distributed with all products sold in New York State and be in the possession of the user at the time of pesticide application.
