

# LESCO CrossCheck® 0.096% Plus Fertilizer

## PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS CAUTION

Harmful if absorbed through skin. Avoid contact with skin, eyes, or clothing. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet. Remove and wash contaminated clothing before reuse.

### ENVIRONMENTAL HAZARDS

This pesticide is extremely toxic to fish and aquatic invertebrates. Do not apply when the weather conditions favor drift from treated areas. Drift and run-off from treated areas may be hazardous to aquatic organisms in neighboring areas. To protect the environment, do not allow pesticide to enter or run off into storm drains, drainage ditches, gutters or surface waters. ### DIRECTIONS FOR USE

### USE RESTRICTIONS:

- Do not apply more than 414 pounds of LESCO CrossCheck 0.096% Plus Fertilizer per acre per year.
- Do not water to the point of run-off.
- Do not make applications during rain.
- Not for use on golf courses, sod farms, nurseries, commercial greenhouses, or grass grown for seed.
- In New York State, this product may NOT be applied to any grass or turfgrass within 100 feet of a water body (lake, pond, river, stream, wetland, or drainage ditch).
- In New York State do make a single repeat application of LESCO CrossCheck 0.096% Plus Fertilizer if there are signs of renewed insect activity, but not sooner than 2 weeks after the first application.

### Resistance Management:

Some insects are known to develop resistance to products used repeatedly for control. ## STORAGE AND DISPOSAL

### Prohibitions

Do not contaminate water, food or feed by storage or disposal.

**Pesticide Storage:** Keep out of reach of children and animals. Store in original containers only. Store in a cool, dry place and avoid excess heat. Carefully open containers. After partial use close tightly. In case of spill, avoid contact, isolate area and keep out animals and unprotected persons. Confine spills.

To confine spill: Cover to prevent dispersal. Place damaged package in a holding container. Identify contents.

### LAWN AND PERIMETER APPLICATIONS

**Perimeter Application:** Apply to ground area 6 to 10 feet wide around and adjacent to the structure using an application rate of 4.75 pounds per 1,000 square feet.

**Lawn Application:** Broadcast LESCO CrossCheck 0.096% Plus Fertilizer with suitable application equipment to ensure uniform coverage over the treatment area. Apply 2.4 to 4.8 pounds per 1,000 square feet to control the following pests:

### Note:

<sup>1</sup> Deer Ticks (Ixodes sp.) have a complicated life cycle that ranges over a two year period and involves four life stages. Applications should be made in mid to late-spring to control larvae and nymphs that reside in the soil and leaf litter.

<sup>2</sup> Imported Fire Ants: Control will be optimized by combining broadcast applications (of suitable EPA approved product) that will control foraging workers and newly mated fly-in queens with mound treatments that will control existing colonies.

The higher application rate may be required to control Ants, Centipedes, Chinch Bugs, Fleas, Imported Fire Ants, Millipedes, Mole Crickets & Ticks.
