**LAWN AND PERIMETER APPLICATIONS**

**Perimeter Application:** Apply to ground area 6 to 10 feet wide around and adjacent to the structure using an application rate of 4.75 pounds per 1,000 square feet.

**Lawn Application:** Broadcast LESCO CrossCheck 0.096% Plus Fertilizer with suitable application equipment to ensure uniform coverage over the treatment area. Apply 2.4 to 4.8 pounds per 1,000 square feet to control the following pests:

<sup>1</sup> Deer Ticks (Ixodes sp.) have a complicated life cycle that ranges over a two year period and involves four life stages. Applications should be made in mid to late-spring to control larvae and nymphs that reside in the soil and leaf litter.

<sup>2</sup> Imported Fire Ants: Control will be optimized by combining broadcast applications (of suitable EPA approved product) that will control foraging workers and newly mated fly-in queens with mound treatments that will control existing colonies.

The higher application rate may be required to control Ants, Centipedes, Chinch Bugs, Fleas, Imported Fire Ants, Millipedes, Mole Crickets & Ticks.
